EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 22 of 2021, Salaries – Army Combat Engineer employment category – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedules B.9 and B.11 of the Principal Determination to add, remove or rename employment categories that relate to Combat Engineers.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 20 January 2022.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1–Combat engineer employment categories amendments

Sections 1 to 7 amend the tables for Pay Grades 4, 6, 7 and 8 in Part 2 (Army) of Schedule B.9 (Warrant Officer pay grades) of the Principal Determination. The tables list the employment categories in Army that are placed in Pay Grades 4, 6, 7 and 8. The amendments update Army's Combat Engineer employment category skill grades and their placements resulting from the reforms associated with Matter 11 of 2021. The amendments omit 'Combat Engineer Manager Grade 1 Tier A' from Pay Grade 4, omit 'Combat Engineer Manager Grade 2 Tier B' and 'Supervisor Explosive Ordnance Disposal Tier A' from Pay Grade 6, omit 'Supervisor Explosive Ordnance Disposal Tier B' from Pay Grade 7, and omit 'Combat Engineer Manager Grade 2 Tier C' and 'Supervisor Explosive Ordnance Disposal Tier C' from Pay Grade 8. The tables are also amended to insert 'Combat Engineer Explosive Ordnance Disposal Manager' and 'Combat Engineer Manager Grade 3' Tier A, B and C into Pay Grades 6, 7 and 8.

Sections 8 to 20 amend the tables for Pay Grades 3 to 6 in Part 2 (Army) of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The tables list the employment categories in Army that are placed in Pay Grades 3 to 6. The amendments update Army's Combat Engineer employment category skill grades and their placements resulting from the reforms associated with Matter 11 of 2021. The table is amended to omit 'Combat Engineer Section Commander' from Pay Grades 3 and 4, omit 'Crewman Commander (Royal Australian Engineers)', 'Operator Specialist Vehicles (Royal Australian Engineers)' and 'Combat Engineer Manager' from Pay Grade 4, omit 'Explosive Detection Dog Handler' and 'Explosives Ordnance Reconnaissance Technician' from Pay Grade 5, and omit 'Assistant Supervisor Explosive Ordnance Disposal', 'Explosive Ordnance Disposal Technician', and 'Supervisor Explosive Ordnance Disposal' from Pay Grade 6. The tables are also amended to insert 'Combat Engineer Section Commander' into Pay Grades 4 and 5, insert 'Combat Engineer Dry Support Bridge' and 'Combat Engineer Operator Engineer Vehicle' into Pay Grade 4, insert 'Combat Engineer Explosive Detection Dog Handler', 'Combat Engineer Explosive Ordnance Reconnaissance', and 'Combat Engineer Section Commander Grade 3 Explosive Detection Dog' into Pay Grade 5, and insert 'Combat Engineer Explosive Ordnance Disposal Manager, Operator & Supervisor' and 'Combat Engineer Manager Grade 3' into Pay Grade 6.
