EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 25 of 2021, Salaries – Navy Information Warfare Officer employment category – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Part 2 of Schedule B.2 of the Principal Determination to add the Information Warfare Officer employment category into the Graded Officer Pay Structure for Navy.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 3 March 2022.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1–Navy Information Warfare Officer employment category amendments

Sections 1 to 8 amend the tables for Pay Grades 2 to 9 in Part 2 (Navy) of Schedule B.2 (Officer pay grades) of the Principal Determination. The tables list the employment categories in Navy that are placed in Pay Grades 2 to 9. The tables are amended to insert 'Information Warfare Officer' into Pay Grades 2 to 9 in Part 2.
